Introduction

The NHS Greater Glasgow and Clyde (NHSGGC) Medicines Information and Governance (MI&G) delivers a range of pharmacy-led services aligned to priorities from local prescribing and therapeutics committees. As well as the core element of enquiry answering, MI&G proactively supports safe and clinical effective use of medicines via development and maintenance of resources such as the Formulary, Therapeutics Handbook (TH) and Medicines Update (MU) blogs across 5 teams. MI&G also provides training to groups including pre and post registration foundation pharmacists, mainly by the enquiry answering team.

NHS Education for Scotland (NES) Post-Registration Foundation programme for Newly Qualified Pharmacists (NQPs)


This new programme is designed to develop pharmacist independent prescribers with the knowledge, skills and behaviour to deliver safe and effective holistic person-centred pharmaceutical care. A key difference from the previous NES framework was the removal of the medicines information element for acute sector pharmacists which included a minimum of 3 complex enquiries.

Launch of this new programme created an opportunity to review our training to cover all aspects of MI&G and to support NQPs' knowledge and experience in areas such as prescribing governance and development of prescribing support materials for wide audiences of healthcare professionals as well as patient specific enquiry answering.

Aim

To develop a new placement to support NQPs in acute hospitals to:

- contribute to the different strands of work in the wider MI&G team;
- develop knowledge and skills in areas such as communication, answering questions about medicines, workload prioritisation, literature searching;
- demonstrate learning outcomes across the domains of the new programme.



NQP Feedback

Answered by 10 out of 14 NQPs who had completed a placement by May 2023.

Key findings:

Following the placement 9/10 NQPs say they felt:





Confident to provide evidence-based information on medicines



More aware of resources to use to find evidence-based information on medicines





When asked 'How useful the placement was in meeting learning outcomes from the programme' the average rating was 4.



When asked 'How easy it was to complete supervised learning events as evidence for the programme' the average rating was 4.

8/10 NQPs would recommend the placement to colleagues and 2/10 would maybe recommend

10/10 NQPs felt more aware of the work of the MI&G teams following the placement
