a CoAcS product, developed through a collaborative effort with WMAS

A new web-based version of MiDatabank is coming!

CoAcS and the WMAS project team are working hard to deliver MiDBOnline to the UKMi network as soon as possible.

User testing will start in the next few months.



WHAT IS USER TESTING?

User testing involves a sandbox environment which will allow users to test the functionality of the 'offline' version of MiDBOnline. It will allow us:

- to get a feel for the new system
- put the system through its paces using example enquiries to test its function

The project team will start the first rounds of user testing with CoAcS in the next few months

- initially in a handful of centres in Wales
- subsequent rounds will involve **selected other sites and centres** from the user group
- we will be in touch with the selected sites closer to the time



User feedback during testing will allow CoAcS to tweak the new system before its launch

INFORMATION GOVERNANCE (IG) AND CYBER SECURITY

IG arrangements and cyber security requirements are not straightforward. MiDBOnline is a web-based solution that will be storing sensitive data in the cloud rather than on a locally-hosted server.

Work is ongoing between CoAcS and the local WMAS IG and cyber security teams to resolve potential problems before its launch.

WMAS project team will share the relevant DPIA and cloud-based security risk assessment forms prior to launch.

To ensure a smooth roll out, we recommend that you make contact with your local IT IG and cyber security departments **NOW** and find out what their local processes are to approve the use of the new system.

COST

The new design with enhanced functionality and increased security requirements come at a cost.

More detail of the subscription cost will be provided by CoAcS.



WHAT ABOUT MIDATABANK DESKTOP?

There are no plans to turn off MiDatabank desktop. You will be able to subscribe to it in the short-term, but you are encouraged to switch over to MiDBOnline to access the improved functionality.

You will have 'read-only' access to the desktop system when you switch to MiDBOnline.

It won't be an active database with ongoing maintenance, as CoAcS will be focusing on MiDBOnline.

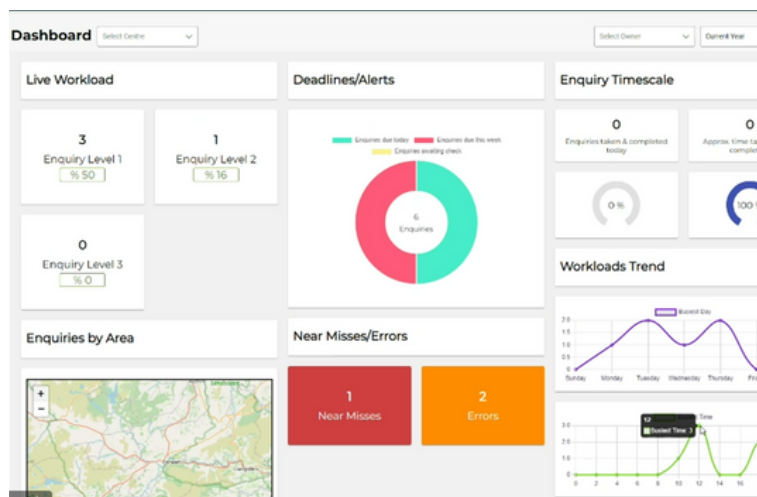

REPORTING, INCLUDING LIVE DASHBOARD

The dashboard will be configurable to suit the needs of your centre or the group of centres you work with.

MiDBOnline will have all of the current reporting function of the desktop version, plus more!

Further improvements are planned for future iterations of the system.



SHARING ENQUIRIES

CoAcS will be sharing more details on this very soon.

The current MiSharer functionality will be integrated into MiDBOnline.

Sharing of enquiries is optional and will be configurable within user / centre permissions.



TRAINING

There will be a built-in help menu, including 'walk-through' videos, and prompts for the user.

The solution has been designed to be intuitive to use.

A webinar for the UKMi network is planned for the late Autumn 2024.

There will be no MiDatabank Trainer version of MiDBOnline.
